Our School Improvement Priorities for 2023-24-25-26

Many thanks to those of you who replied to our survey to help prioritise our School Improvement Plan areas for the next three years. We were very pleased with the number of responses from families, pupils, colleagues and local stakeholders who we work with in and around Huntly. All the responses were collated to identify the top areas which people felt were most important. We have built three plans around these priorities, detailed below. We'll let you know every year how we are progressing and what our next steps are.

Plan 1:

- Develop & create opportunities for positive wellbeing outcomes to be met across our whole-School community
- Ensure consistent positive, supportive & inclusive relationships in all areas of learning
- Maximise successes and achievements, particularly for those facing most disadvantage

Plan 2

- Ensure consistent high-quality, inclusive learning, teaching & assessment
- Engage and challenges all young people, facilitate their voice
- Provide more reliable formative and summative data to support improvements, achievement & attainment

Plan 3:

- Review and restructure our curriculum to build successful outcomes for all;
- Finalise our skills framework to embed and connect it with learning for life & work in just & sustainable communities, both locally and globally

SQA coursework 2023-24

For pupils in S4, S5 and S6 this school session, the SQA have re-instated some additional coursework in many subjects, called an 'Assignment' or a 'Project'. These will be completed at various points throughout the session, depending upon the subject. The marks from these count towards the overall final SQA mark and grade that your child will receive in August 2024.

It is vital that your child is in school when these assessments take place and that if there is any preparatory work allowed, anything taken from on-line sources is clearly and explicitly referenced, to avoid 'plagiarism' (passing-off someone else's work as your own). If it is found that any coursework is not the pupil's own, then they risk losing that entire qualification. Pupils should also not use any form of artificial intelligence to aid their coursework completion. The SQA do have and use software to detect this and again, the qualification may be lost.

Please do speak with your child to ensure that they are aware of all the coursework requirements and deadlines for each subject they are taking this session. Pupils will receive a booklet shortly from the SQA via ourselves around their coursework requirements that will reinforce the above. School uniform and dress code: survey responses

We conducted a family survey at the end of last term around our uniform and dress code options. The Gordon Schools has a 'dress code', meaning that we have a range of options young people can wear as a part of their uniform here. Dress code and uniform are a School expectation. They are a social contract with families attending TGS, who have the responsibility for sourcing uniform and clothing their young people each day. We want young people's dress to be smart and safe.

Please see below the results of the family survey we conducted at the end of the last school session. We received 115 responses to the survey, and this is between 20% - 25% of our parent/carer body. Many thanks to those who did reply, it is much appreciated.

Will you support TGS by ensuring your child/children come to school wearing dress code? Yes or No: 115 responses of which 110 were 'Yes' and 5 were 'No'

Do you want to be informed if your child / children is not wearing uniform from our Dress Code?

Yes or No: 115 responses of which 76 were 'Yes' and 39 were 'No'

Would you like to suggest any changes to our current dress code? Yes or No: 115 responses of which 44 were 'Yes' and 71 were 'No'

Responses received were very varied and mentioned:

 the costs associated with uniform at a time when many families are finding finance an issue

- the need to be sensitive to pupils with sensory issues in terms of their clothing
- the need for our suppliers to keep their website and stock up-to-date
- some wanted hoodies and others did not; similarly with blazers
- some wanted smart quality black shorts for the summer
- some made the link between uniform and expectations of dress code in the workplace

Are you happy with the different places you can get uniform items from? Yes or No: 115 responses of which 101 were 'Yes' and 14 were 'No' Responses received mentioned:

- the quality and durability of some suppliers items
- high costs and lack of choice
- issues with getting accurate sizing

We will continue to work with our suppliers around keeping websites up-to-date and ask that you support the School by keeping your child/ren as smartly dressed as possible, using our TGS Dress Code and Uniform options.

black polo; black jumper; black sweatshirt; black hoodie; black blazer (School coat of arms added by supplier). Some pupils also prefer a white polo; white shirt (with/without a School tie). Trousers or skirt in black, thick material (**not** see-through leggings, crop tops, short Lycra-style shorts).

The Gordon Schools Guidance Team Update

The Guidance Team are delighted to share some positive updates with you, particularly regarding our recent move to a collaborative Team office within the School building. This change marks a significant step forward in enhancing our support for students and fostering a consistent supportive environment.



One of our primary focus areas this term has been addressing critical concerns relevant to our students' well-being. Across all year groups, we have been actively engaging in open and honest discussions about the rising issue of vaping. By imparting knowledge and facilitating dialogue, we aim to equip our students with the information and skills necessary to make

informed choices. There is family information accompanying this Newsletter to support discussions.

Our S2 students have been delving into comprehensive Relationship and Sexual Health Education, fostering a healthy and respectful understanding of these important aspects of life. Moving into S3, the spotlight is on Mental Health. Recognising the importance of mental well-being.

In S4, our focus shifted towards a thorough exploration of cannabis use, ensuring that students are equipped with accurate information to make responsible decisions regarding their health. This year, we've taken a fresh approach to Personal and Social Education (PSE) for our S5 students. We of hosting several engaging speakers, including representatives from Aberdeenshire employability programmes, Aberdeen mountain rescue team, and higher education institutions.

These sessions aim to broaden our students' horizons, offering insights into various career paths and opportunities beyond the classroom.



Our S6 students have received extensive support and guidance in navigating the complex landscape of UCAS applications and personal statements.



Mobile phones and Responsible social media use

In order to support teachers with learning, assessment & teaching in School, we ask that if you need to speak directly with your child during the hours of learning (08:55 – 10:55 / 11:15 – 13:00 & 14:00 – 15:45), please contact our School Office colleagues (number below), who can facilitate this for you rather than phoning your child's mobile phone. Our Mobile Phone policy gives teachers the discretion over whether it is appropriate for phones to be available for pupil use during learning.

Irresponsible social media use is a growing issue and causing unhappiness and breakdowns in relationships between pupils. A further worrying trend is the number of fake sites and social media accounts that claim to represent The Gordon Schools, but by their vile, abusive and disgusting content, clearly do not. These target both pupils and staff colleagues and we are working with Police Scotland and online support organisations to combat these.

There are however, many pupils who choose to follow these sites as well as the few who set them up. Again, we would ask that you speak with your child around their online presence and ensure that they are aware of the hurt and damage to everyone in our community that is being caused by irresponsible and inappropriate use.
